

## Continuing Seamless Summer Option (SSO) in Summer

### SSO Requirements

<b>School Sponsor</b>	SSO is only an option for school sponsors.
<b>Sites Must be Area Eligible</b>	<ul style="list-style-type: none"> <li>Based on school, census, or other approved data.</li> <li>Contact your Child Nutrition Consultant for assistance with determining whether your site(s) are eligible to operate SSO.</li> </ul>
<b>Meal Pattern</b>	<ul style="list-style-type: none"> <li>NSLP/SBP Meal Pattern</li> </ul>
<b>Monitoring</b>	<ul style="list-style-type: none"> <li>Review of meal counting, claiming, and meal pattern compliance at least once during each site's operation in each program year.</li> <li>If site operates during the school year, review may have already been completed.</li> </ul>

### KN-CLAIM Updates Required for SSO Election

<b>SNP Sponsor Application</b>	Update in May 2022: <ul style="list-style-type: none"> <li>Review to ensure all information is accurate.</li> </ul>
<b>SNP Site Application(s)</b>	Update in May 2022: <ul style="list-style-type: none"> <li>Top of application: Uncheck "This site will be serving meals and/or snacks through the SSO during the 2021-2022 school year," then save the application.</li> <li>Field 14: Check June as an SSO month of operation. If operating SSO in July, it will be included in the PY23 site application(s). Uncheck NSLP and SBP months of operation.</li> <li>Fields 40-48: Enter site qualification information.</li> <li>Field 60: Enter June operating dates.</li> <li>Fields 61-67: Update meal service information.</li> <li>Fields 104-122: Update SSO selections (far right), as needed. Uncheck breakfast and lunch selections.</li> </ul> <p>Save application updates. Email your consultant to notify of changes.</p>
<b>Waiver Application(s)</b>	Update in May 2022: <ul style="list-style-type: none"> <li>Review to ensure waivers are up to date.</li> <li>Waiver allowing School Meal Pattern Flexibility is only applicable until June 30, 2022.</li> </ul>
